SETTLEMENT OF K. HOVNANIAN LITIGATION

Review and determination of amended 2015 Settlement Agreement for litigation between Arno Holdings, LLC, successor in interest to Alfred Bluh and Shirley Bluh and Batelli Family, LLC, a successor in interest to Joseph Batelli and the Township of Marlboro and the Planning Board of the Township of Marlboro, for approximately 86 acres of land located in the Township of Marlboro , Block 150 Lots 2, 3, 4 and 9; Block 151 Lot 4; Block 148 Lot 31; and Block 49 Lot 16, with frontage along Route 79, Church Lane and Tennent Road.

Michael Herbert, Esq. reviewed the proposed settlement of the litigation along with the December 1, 2015 CME Associates' evaluation.

The Board finds that the Amended 2015 Settlement Agreement is a favorable result for the Township in that it satisfies our affordable housing and open space needs without having a negative impact upon the Townshio Master Plan, local zoning or the public's health, safety and welfare.
