P.B. 1150-17 JULIA SWITZER-BRANDON – EXTENSION OF TIME

Salvatore Alfieri, Esq. represented the applicant. The applicant was granted Minor Subdivision Approval by Resolution dated April 19, 2017.

According to Municipal Land Use Law a Minor Subdivision is to be perfected within 190 days of the resolution. The applicant has received Conditional Final Approval from the Monmouth County Planning Board. They are in the process of obtaining approval from the NJDOT.

The applicant is requesting a 120 day Extension of Time in which to perfect the subdivision approval.

P.B. 1165-17 IGS SOLAR, LLC – PUBLIC HEARING – MINOR SITE PLAN

Mr. Herbert, Esq. noted that the affidavit of publication and notice to adjoining property owners have been reviewed and are in order, therefore, the Board has the jurisdiction to hear this matter.

Salvatore Alfieri, Esq. represented the applicant. The site contains 260 feet of frontage along the east side of Main Street(Route 79) and 215 feet of frontage along the south side of Route 520, Block 213 Lot 10, within the R30/20 zone. Currently, the property contains a house of worship(Saint Gabriel's) with associated parking areas having access by a one way entry drive and one way exit drive along Route 79 as well as an apparent full movement drive along Route 520.

Thomas Roesch, P.E. testified on behalf of the applicant. The applicant is seeking approval to install a ground mounted solar panel array field (approximately 800 panels near the rear northeast corner of the overall property to assist with the electric needs of the church, parish hall and rectory buildings. The proposed array field would be located within a cleared portion of the property north of a stormwater basin area and east of onsite parking. The proposed array field is indicated to encompass a total area of approximately 39,271 s.f. (173 feet 2 227 feet) within a 6 foot high chain link fence enclosure and the proposed panels are indicated too have an overall height of approximately 7.5 feet above ground. The panels will be serviced two time per year.
