# <u>P.B. 1169-18 LUCAS DEVELOPMENT, LLC. – PUBLIC HEARING – AMENDED</u> <u>PRELIMINARY & FINAL SITE PLAN</u>

Mr. Herbert, Esq. noted that the affidavit of publication and notice to adjoining property owners have been reviewed and are in order, therefore, the Board has the jurisdiction to hear this matter.

Salvatore Alfieri, Esq. represented the applicant. The 1.2 acre site contains 165 feet of frontage along the north side of Commercial Court, west of the Tennent Road intersection, within the IOR zone, Block 172 Lot 40.03. The property is located within an industrial/office park complex and currently contains a two story warehouse/commercial building having 2 apparent full movement access drives along commercial Court with parking for 35 vehicles to the rear and west of the building.

Joseph Kociuba, P.E. testified on behalf of the applicant. Entered into evidence were the following exhibits:

- A-1 Colored Site Plan, dated February 9, 2018
- A-2 Colored Photos of the site

The applicant is seeking Site Plan approval to construct a 4,180 s.f. two story building addition, including wall mounted lighting along the rear of the existing building and reconfiguration of onsite parking to provide 33 spaces, a proposed reduction of 2 spaces from existing.

Aurora Multi Media is currently the tenant. The hours of business are 9:00 a.m. to 5:00 p.m with 25 employees. This is an electronic assembly plant that does not produce any toxins. There will be one single axle truck delivery per week.

Mr. Kociuba reviewed the runoff stormwater with the Board and stated that this addition presented no changes.

Ms. Neumann, P.E., P.P. reviewed her report with the Board.
