LEGISLATIVE MINUTES

MARLBORO TOWNSHIP COUNCIL MEETING

July 16, 2020

The Marlboro Township Council held its regularly scheduled meeting remotely on July 16, 2020 at 7:00 P.M.

Council President Mazzola opened the meeting and announced that pursuant to the provisions of the Open Public Meetings Act, notice of this regularly scheduled meeting of the Township Council of the Township of Marlboro was sent to the Asbury Park Press, the Star Ledger, News Transcript and Board of Education Office on January 7, 2020; published in the Asbury Park Press on January 9, 2020; posted on the Bulletin Board of the Municipal Building; filed in the office of the Municipal Clerk and placed on the township website and Channel 77.

The Clerk called the Roll.

PRESENT:

Council Vice President Cantor, Councilwoman Marder, Councilman Scalea and Council President Mazzola by conference call. Councilman Metzger was absent.

Councilman Scalea moved that the minutes of June 18, 2020 be approved. This was seconded by Council President Mazzola and passed on a roll call vote of 2 - 0 in favor (Abstain: Cantor, Marder) (Absent: Metzger).

A RESOLUTION AUTHORIZING AN AMENDMENT TO THE PROFESSIONAL SERVICES CONTRACT BETWEEN CME ASSOCIATES AND THE TOWNSHIP OF MARLBORO FOR PROFESSIONAL ENGINEERING SERVICES IN CONNECTION WITH THE ROCKWELL CIRCLE DAM

WHEREAS, the Township authorized various infrastructure improvements as part of its 2015 Capital Program which included engineering services in connection with the Rockwell Circle Dam (060-28) ("Project"); and

WHEREAS, the NJ Department of Environmental Protection (NJDEP) has since confirmed the classification of the Rockwell Circle Dam as a Class III Low Hazard Dam; and

WHEREAS, as a Class III Low Hazard Dam, the structure on Rockwell Circle requires regular inspection and reporting to ensure full compliance with the Dam Safety Standards (N.J.A.C. 7:2-1.8a); and

WHEREAS, the Township received a communication dated June 12, 2020 from NJDEP on June 23, 2020 requiring that a "Regular Dam Safety Inspection" report be submitted by August 31, 2020; and

WHEREAS, the Township is in need of professional engineering services in connection with this Project and has been provided with a proposal by CME Associates dated July 1, 2020 ("Proposal") for such Professional Services; and

WHEREAS, the Township of Marlboro and CME Associates have entered into a Professional Services Contract, awarded under a fair and open process, and seeks to amend such Contract to expand the scope of services to include the Professional Services (as defined hereinabove) for the Project at a fee not to exceed \$5,000.00 for such Professional Services, as further described and set forth in CME's proposal, attached hereto and made a part hereof; and

WHEREAS, the value of the Professional Services Contract will exceed \$17,500.00 in the aggregate; and

WHEREAS, the Chief Financial Officer has certified that funds are available for this purpose from Account #04-215-15-02I-060288; and

WHEREAS, the Township Council has deemed it necessary and in the best interest of the Township of Marlboro to amend its contract with CME Associates to provide the required additional Professional Services for the Project in accordance with the Proposals; and

WHEREAS, the services to be provided are considered to be "Professional Services" pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the Local Public Contracts Law authorizes the awarding of a contract for "Professional Services" without public advertising for bids and bidding therefore, provided that the Resolution authorizing the contract and the contract itself be available for public inspection in the office of the Municipal Clerk and that notice of the awarding of the contract be published in a newspaper of general circulation in the municipality; and

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED, by the Township Council of the Township of Marlboro that a Professional Services Contract between CME Associates and the Township of Marlboro, to expand the scope of services to include PROFESSIONAL ENGINEERING SERVICES IN CONNECTION WITH THE ROCKWELL CIRCLE DAM by way of its Township Engineers ("Professional Services"), at a fee not to exceed \$5,000.00 for such Professional Services, as further described and set forth in CME's Proposal dated July 1, 2020, be and is hereby authorized; and

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized to execute, and the Clerk to witness, in a form legally acceptable to the Township Attorney, the Professional Services Contract described herein; and

BE IT FURTHER RESOLVED, that this Professional Services Contract is awarded without competitive bidding pursuant to $\underline{\text{N.J.S.A}}$. 40A:11-5(1) (a) (i) and shall provide for compensation in an amount not to exceed \$5,000.00 for such additional Professional Services for the Project as described in the proposal; and

A RESOLUTION AUTHORIZING FINAL CLOSEOUT CHANGE ORDER TO THE EXISTING CONTRACT BETWEEN THE TOWNSHIP OF MARLBORO AND EARLE ASPHALT COMPANY AND AUTHORIZING FINAL PAYMENT AND ACCEPTANCE OF THE PLEASANT VALLEY ROAD STREAM BANK STABILIZATION, PHASE II

WHEREAS, on November 14, 2019 by Resolution #2019-322 the Township of Marlboro authorized the award of a contract to Earle Asphalt Company for the Pleasant Valley Road Stream Bank Stabilization, Phase II (the "Project"); and

WHEREAS, a Closeout Change Order has been requested resulting in a decrease in the original contract amount of \$515,113.13 to \$484,554.33, a net decrease of \$30,558.80; and

WHEREAS, in a memo dated July 8, 2020, the Township Engineer has certified that the project was completed in accordance with the approval of the Closeout Change Order, and has recommended acceptance of the Project improvements and issuance of final payment in the amount of \$9,691.09; and

WHEREAS, pursuant to the terms of the contract, Earle Asphalt Company has provided a two-year maintenance bond in an amount equal to 15% of the final contract amount or \$72,683.15; and

WHEREAS, the Township Council of the Township of Marlboro is amenable to approving Closeout Change Order, accepting the Project improvements and issuing a final payment to Earle Asphalt Company in the amount of \$9,691.09 in order that the Project be completed, such Project being in the interests of the public health, safety and welfare.

A RESOLUTION AUTHORIZING THE EXTENSION OF A TEMPORARY USE AND OCCUPANCY AGREEMENT FOR THE PARCEL OF LAND OWNED BY THE TOWNSHIP OF MARLBORO KNOWN AS THE "STATTEL FARM (STAND)" (BLOCK 206/LOT 25) LOCATED AT COUNTY ROUTE 520 and STATE HIGHWAY 79

WHEREAS, the Township of Marlboro acquired the Stattel Farm(stand) (Block 206/Lot 25) ("parcel") located at County Route 520 and State Highway 79 in February, 2017 from the Stattel Family; and

WHEREAS, the Stattel Family farmed the parcel continuously up until the time of sale, and harvested the season's crops under a Use & Occupancy Agreement with the Township which expired on June 30, 2017; and

WHEREAS, October 5, 2017 (R.2017-287) the Township Council of the Township of Marlboro authorized a Use and Occupancy agreement with the Stattel Family for the continued farming of the parcel which expired on July 31, 2018; and

WHEREAS, June 12, 2018 (R.2018-228) the Township Council of the Township of Marlboro authorized a renewal of the Use and Occupancy agreement with the Stattel Family for the continued farming of the parcel which expires on July 31, 2019; and

WHEREAS, July 11, 2019 (R.2019-219) the Township Council of the Township of Marlboro authorized a renewal of the Use and Occupancy agreement with the Stattel Family for the continued farming of the parcel which expires on July 31, 2020; and

WHEREAS, pursuant to N.J.S.A. 40A:12-14.1, "Whenever a county or municipality acquires real property that, immediately prior to acquisition, was leased from the prior owner by a private person for agricultural or horticultural use, and the county or municipality determines that, until such time as the real property is needed for

public use, the temporary continuance of the private agricultural or horticultural use would not compromise that public use, it may lease the real property to the prior lessee for agricultural or horticultural use for such period, consideration, and other terms and conditions as shall be mutually agreed upon; and

WHEREAS, the Township is in the process of working with both the State Agricultural Development Committee on the permanent preservation of the parcel; and

WHEREAS, it is in the interest of the Township for crops to be planted during the fall season and to have the parcel continuously farmed during the preservation process; and

WHEREAS, the Township and Stattel Family have agreed to renew the Use and Occupancy agreement under the same terms for the farming of the parcel in the 2020-2021 season.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED, by the Township Council of the Township of Marlboro, that an agreement be executed with Stattel Family, PO BOX 122, Marlboro, NJ 07746 for the TEMPORARY USE AND OCCUPANCY OF LAND OWNED BY THE TOWNSHIP OF MARLBORO KNOWN AS THE "STATTEL FARM(STAND)" (BLOCK 206/LOT 25) LOCATED AT COUNTY ROUTE 520 AND STATE HIGHWAY 79, for a term beginning August 1, 2020 and ending on July 31, 2021, in the amount of \$700.00.

WHEREAS, the Township has generated an additional 92 SRECs for the EY2020 period; and

WHEREAS, Township's Broker, Marex Spectron confirmed a price of \$228.00 per SREC for the additional 92 SRECs (EY 2020); and

WHEREAS, pursuant to R.2018-264 and 2019-113, the Township accepted the offer of \$228.00 per SREC for 92 SRECs (EY 2020) by Spectron Energy, 360 Madison Avenue, Third Floor, New York, NY 10017.

NOW THEREFORE BE IT RESOLVED that the Township Council hereby confirms the acceptance of the offer by Spectron Energy, 360 Madison Avenue, Third Floor, New York, NY 10017 to purchase 92 SRECS (EY 2020) at a price of \$228.00 per SREC.

WHEREAS, $\underline{\text{N.J.S.A}}$. 40A:11-6 states that "Any contract may be ... awarded for a contracting unit without public advertising for bids and bidding therefor ... when an emergency affecting the public health, safety or welfare requires the immediate ... performance of services"; and

WHEREAS, $\underline{\text{N.J.S.A}}$. 40A:11-6(b) states that "Upon the furnishing of such goods or services ... the contractor furnishing such goods or services shall be entitled to be paid therefor and the contracting unit shall be obligated for said payment ..."; and

WHEREAS, the condition posed a serious threat to the public health, safety and welfare, constituting an emergency under the terms of N.J.S.A. 40A:11-6; and

WHEREAS, pursuant to $\underline{\text{N.J.S.A}}$. 40A:11-6, the Water Utility contacted its existing emergency water main repair contractor, LUCAS CONSTRUCTION GROUP, INC., 173 Amboy Road, Morganville, NJ 07751 to provide the emergency repairs related to the above mentioned emergencies in an amount of \$335,167.46; and

WHEREAS, pursuant to N.J.S.A. 40A:11-6, the Township contacted its existing water distribution product supplier, WATER WORKS SUPPLY CO., INC., 660 State Highway 23 P.O. Box 306, Pompton Plains, New Jersey 07444 to provide the necessary emergency water distribution products related to the above mentioned emergencies in an amount not to exceed \$76,238.82; and
