ORDINANCE # 2021-002

ORDINANCE AUTHORIZING THE TOWNSHIP OF MARLBORO TO ACQUIRE NON-EXCLUSIVE EASEMENTS OVER PROPERTY (BLOCK 157, LOTS 34.03 & 34.02) WHEREAS, New Hope Integrated Behavioral Health Care ("New Hope Care") and Recovery Management Systems, Inc. ("Recovery Management") are the owners of certain tracts or portions of property identified on the Township of Marlboro (the "Township") Official Tax Map as Block 157, Lot 34.03 and Block 157, Lot 34.02, respectively (hereinafter referred to as the "Property"); and

WHEREAS, the Township seeks to acquire non-exclusive easements and rights-of-way in perpetuity for the operation, maintenance, monitoring, repair, renewal and/or replacement of certain water system improvements that are located and/or to be constructed upon a portion of said Property (the "Easements"); and

WHEREAS, pursuant to N.J.S.A. 40A:12-1, et seq., the Local Lands and Buildings Law, the Township is authorized to acquire any real property, or interests therein, when authorized by ordinance; and

WHEREAS, Deeds of Easement and Rights-of-Way from New Hope Care and Recovery Management have been prepared which provide the Township with non-exclusive easements in the Property as described in the agreements appended hereto as Attachment A and Attachment B; and

WHEREAS, after analysis and review, the Marlboro Township Division of Engineering ("Engineering"") has determined it is in the Township's best interest to enter into the aforementioned Deeds of Easement and Rights-of-Way in a form substantially similar to the forms attached hereto as Attachment A and Attachment B; and

WHEREAS, the Township Attorney has reviewed the aforementioned Deeds of Easement and Rights-of-Way and agreed that it is in the best interests of the Township to acquire the easements; and

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Marlboro, County of Monmouth, State of New Jersey, as follows:

 The Mayor and Municipal Clerk are hereby authorized to execute all documents necessary for the acceptance of the Deeds of Easement and Rights-of-Way as described in substantially the forms appended hereto as Attachment A and Attachment B, which set forth the terms and conditions pertaining to the easements.

- 2. If any section or provision of this Ordinance shall be held to be invalid by any court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance.
- 3. All ordinances or part of ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.
- 4. This Ordinance shall take effect immediately after final passage and publication in the manner provided by law.

RESOLUTION #2021-059

AN AMENDED RESOLUTION OF THE MARLBORO TOWNSHIP TOWN COUNCIL AUTHORIZING A SUBORDINATION OF A MORTGAGE DATED NOVEMBER 9, 2011, AGAINST A PROPERTY LOCATED AT 2 SHERBROOKE LANE, MORGANVILLE, NEW JERSEY, AND OWNED BY BARRY J. IVLER AND BONNIE JAY IVLER, HUSBAND AND WIFE

WHEREAS, the Township of Marlboro currently operates and participates under the auspices of New Jersey's Fair Housing Act (N.J.S.A. 52:27D-301 et. seq.) as to its affordable housing obligations; and

WHEREAS, the homeowners hereunder, Barry J. Ivler and Bonnie Jay Ivler, husband and wife ("the Homeowners"), purchased a residence which is commonly known as 2 Sherbrooke Lane, in the Township of Marlboro, and said home can be more specifically identified as Lot 13, Block 267 ("the Residence"); and

WHEREAS, the Homeowners previously made application to the then administrative agent as to Marlboro Township's "Housing Rehabilitation Program"; and

WHEREAS, Marlboro's administrative agent issued a "certificate of eligible household" to the Homeowners on July 28, 2011; and

WHEREAS, as part and parcel of participating in the rehabilitation program the Homeowners executed a mortgage to Marlboro Township (dated November 9, 2011) to secure a forgivable loan of \$16,875.00 with said mortgage being recorded on November 8, 2012, in the Monmouth County Clerk's Office in deed book OR-8979, at page 8611 et seq. ("the Marlboro Mortgage"); and

WHEREAS, by virtue of the foregoing, the Residence was made subject to the Marlboro Mortgage and the Uniform Housing Affordability Controls act which is codified at N.J.A.C. 5:80-26.1 et seq.; and

WHEREAS, the Homeowners have now negotiated with The Federal Savings Bank ("the Lender") to refinance their existing first mortgage against the Residence (currently held by PennyMac Loan Services, LLC); and

WHEREAS, as a condition of the imminent refinancing with the Lender, the Lender requires a subordination of the Marlboro Mortgage; and WHEREAS, the Homeowners now desire to refinance and as a consequence thereof, they too ask the Marlboro Township Town Council to approve a subordination of the Marlboro Mortgage in order to facilitate their refinance application; and

WHEREAS, on December 17, 2020, the Township of Marlboro, in the County of Monmouth, New Jersey (the "Township") finally adopted Ordinance #2020-015 (the "Ordinance"), authorizing a special emergency appropriation in the amount of \$1,900,000 to provide for a deficit in operations experienced by the Township during fiscal year 2020, in which a public health emergency pursuant to the "Emergency Health Powers Act," P.L.2005, c.222 (C.26:13-1 et seq.), or a state of emergency, pursuant to P.L.1942, c.251 (C.App.A:9-33 et seq.), or both, has been declared by the Governor in response to COVID 19, in the amount of \$1,900,000, pursuant to 40A:4-53(m) N.J.S.A. (the "*COVID19* Special Emergency Appropriation"); and

WHEREAS, the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey approved the Township's COVID19 Special Emergency Appropriation in the amount of \$1,900,000 in accordance with the provisions of N.J.S.A. 40A:4-53; and

WHEREAS, on December 17, 2020, the Township finally adopted Resolution #2020-327 (the "*Note Resolution*"), authorizing the issuance of not to exceed \$1,900,000 of Special Emergency Notes to fund the COVID19 Special Emergency Appropriation; and

WHEREAS, upon the close of the 2020 fiscal year, the Township has determined to reduce the COVID19 Special Emergency Appropriation by \$1,298,000, from \$1,900,000 to \$602,000, and to cancel such amount of the COVID19 Special Emergency Appropriation; and

WHEREAS, the Township further desires to reduce the amount of Special Emergency Notes authorized by the Note Resolution by \$1,298,000, from \$1,900,000 to \$602,000.

BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

The Township of Marlboro Emergency Management Coordinator is designated to coordinate with other offices and shall periodically report on the activities, accomplishments, and progress, and shall prepare an annual progress report to be submitted to the New Jersey Office of Emergency Management. The status reports shall be submitted on a yearly basis by a predetermined date agree upon by all stakeholders.

A RESOLUTION AMENDING THE DEVELOPER AGREEMENT BETWEEN THE TOWNSHIP OF MARLBORO, AND THE STATE OF NEW JERSEY DEPARTMENT OF TREASURY DIVISION OF PROPERTY MANAGEMENT AND CONSTRUCION, IN CONNECTION WITH PRELIMINARY, TENTATIVE AND FINAL WATER SERVICE APPROVAL FOR THE SITE LOCATED ALONG CONOVER ROAD, BLOCK 159 LOT 11, INCLUDING CONNECTIONS OF LOTS 34.02 AND 34.03, TOWNSHIP OF MARLBORO, MONMOUTH COUNTY, NEW JERSEY

WHEREAS, pursuant to R.2020-144, the Township of Marlboro executed a Developer Agreement with the State of New Jersey State for the construction of a potable water line extension across the former Marlboro Psychiatric Hospital property, intended to service two State-operated Group Homes to be constructed on the property and two privately-owned facilities, RMS New Hope and Discovery and Mattie House; and

WHEREAS, for purposes of administration the Project has been divided into four (4) separate phases, described as follows:

Phase 1, consisting of work presently being performed on Conover Road ("Phase 1");

Phase 2, consisting of work to be performed on Newman Springs Road (County Route 520) ("Phase 2");

Phase 3, consisting of work to be performed from Newman Springs Road to an existing water pipeline on the State Property ("Phase 3"); and

Phase 4, consisting of work to be performed on Pleasant Valley Road ("Phase 4"); and (hereinafter collectively referred to as the "Project");

WHEREAS, in order to allow the State to proceed with work on the Project while the plans for Phase 3 were being revised, the Township agreed to allow for execution of the Developer's Agreement to authorize construction of the Phases 1, 2 and 4 only, the plans for which were completed and approved; and

WHEREAS, the Phase 3 plans have now been finally approved by both the Township's Consulting Engineer and NJDEP; and

WHEREAS, the Township of Marlboro Water Utility Division has granted approval with respect to the water service to the Project and the site and conditioned the approval upon the Developer entering into a Developer Agreement with the Township of Marlboro Water Utility Division and posting all the necessary performance guarantees; and

WHEREAS, the Developer Agreement has been negotiated by the parties, and the negotiation and preparation of same shall be paid for from Developer's escrow account held by the Township of Marlboro; and

WHEREAS, the necessary performance guarantees, cash deposits and insurance certificates shall be subject to the review and approval of the Township Attorney.
