#### MARLBORO TOWNSHIP COUNCIL MEETING

## February 10, 2022

The Marlboro Township Council held its regularly scheduled meeting on February 10, 2022 at 7:00 P.M. at the Marlboro Municipal Complex located at 1979 Township Drive, Marlboro, New Jersey.

Council President Qazi opened the meeting and announced that pursuant to the provisions of the Open Public Meetings Act, notice of this regularly scheduled meeting of the Township Council of the Township of Marlboro was published in the Asbury Park Press on December 21, 2021; was sent to the Asbury Park Press, the Star Ledger, News Transcript and the Board of Education Office on February 7, 2022; posted on the Bulletin Board of the Municipal Building; filed in the office of the Municipal Clerk and placed on the Township website and Channel 77.

The Municipal Clerk called the Roll.

<u>Citizen's Voice</u>: Frank Festa of 1727 Ramapo way Scotch Plains commented about the grading and clearing permit for his property. He would like Council to advise if he is allowed to regrade his land. Township Attorney Louis N. Rainone, Esq. stated that these comments have already been addressed by the engineering department and in responses to Mr. Festa's OPRA requests.

William Waple of 16 Calder Court suggested changing resolution #2022-034 regarding the meeting protocol.

Cheryl Krenkle of 41 Samantha Drive commented about the ongoing construction at 606 Robert Court.

<u>Council Speaks Out</u>: Councilman Scalea thanked Mr. and Mrs. Krenkel for their comments and he looked forward to meeting with them to

discuss their concerns. He congratulated Carol Mazzola on being appointed Deputy Mayor of Economic Development. Councilman Milman stated he was happy to have so many people come out to support the police officers that were recognized for their continued dedication on and off the job. He thanked everyone that signed up for citizen's voice and for coming to the Council meeting. He also congratulated Carol Mazzola on becoming Deputy Mayor.

<u>Presentation</u>: New Jersey Assemblywoman Vicki Flynn, Assemblyman Gerry Scharfenberger and Commissioner Ross F. Licitra presented commendations to the following members of the Marlboro Police Department who distinguished themselves through exemplary law enforcement service and devotion to duty. : Lieutenant Nicholas Szymanski, Sergeant John Bise, Sergeant Andrew Goldberg, and Dispatcher Paul Lorenz.

Administrative Report: Mayor Hornik welcomed Assemblywoman Vicki Flynn, Assemblyman Gerry Scharfenberger and Commissioner Ross F. Licitra to Marlboro to recognize and honor Marlboro's police officers. Summer camp, swim club membership, and spring soccer registrations are open for enrollment. Applications for the 2022 Marlboro community garden season are now being accepted. Members have grown and donated more than 1,000 pounds of produce to local food banks. The Mayor thanked Ellen Simonetti for her leadership running the beautiful garden. The Mayor provided his support for the meeting agenda items including the \$75,000 grant from the NJ Local Government Services. This competitive grant was awarded to the Township for improvements to recreation facilities and parks. He welcomed Carol Mazzola as the Deputy Mayor of Economic Development and looks forward to many more years of working together. In closing the Mayor stated that this weekend would be the last day for the Marlboro COVID Testing Truck. He was pleased to announce that COVID cases and hospitalizations are continuing to decline locally and throughout the country. As of February 2, cases are down 53% from their peak in mid-January and so the demand for testing has declined. If COVID numbers change, the Township will adjust accordingly. Residents can continue to find testing, vaccines or boosters, at the Monmouth County Health Department, they have a number of locations throughout the county. He wished everyone a Happy Chinese New Year, it is the year of the Tiger and a Happy Valentine's Day.

Councilman Scalea moved that the Council meeting minutes of January 26, 2022 be approved. This was seconded by Councilman Milman, and passed on a roll call vote of 3 - 0 in favor. Council Vice President DiNuzzo and Councilwoman Marder were absent.

Councilman Milman offered a motion to reschedule Ordinance #2022-001 to February 24, 2022 without further legal notice, seconded by Councilman Scalea and passed on a roll call vote of 3-0 in favor.

## ORDINANCE #2022-001

AN ORDINANCE AMENDING SECTION 220-8 OF THE CODE OF THE TOWNSHIP OF MARLBORO (APPOINTMENT OF ZONING BOARD MEMBERS)

BE IT ORDAINED, by the Township Council of the Township of Marlboro, that Section 220-8(A) of the Code of the Township of Marlboro shall be amended to read as follows:

A. Establishment and composition.

- (1)A Zoning Board of Adjustment is hereby established pursuant to N.J.S.A. 40:55D-69 et seq., as amended, consisting of seven residents of the Township of Marlboro appointed by the Township Council to serve for terms of four years from January 1 of the year of their appointment. The terms of the members first appointed shall be so determined that to the greatest practicable extent the expiration of such terms shall be distributed evenly over the first four years after their appointment; provided that the initial term of no member shall exceed four years. Thereafter, the term of each member shall be for four years. Nothing in this chapter shall, however, construed to affect the term of any present member of the Zoning Board of Adjustment, all of whom shall continue in office until the completion of the term for which they were appointed.
- (2) No member of the Zoning Board of Adjustment may hold any elective office or position under the Township, except that one member may be a member of the Planning Board.
- (3) A vacancy occurring otherwise than by expiration of term shall be filled for the unexpired term only.
- (4) There shall be two alternate members appointed by the Township Council and designated by the Township Council as "Alternate No. 1" and "Alternate No. 2," each for a term of two years. Alternate members may participate in discussions of the proceedings but not vote except in the absence or disqualification of a regular member. A vote shall not be delayed in order that a regular member may vote instead of an alternate member. In the event that a choice must be made as to which alternate member is to vote, Alternate No. 1 shall vote.
- (5) Quorum. If the Zoning Board of Adjustment lacks a quorum because any of its regular or alternate members is

prohibited by N.J.S.A. 40:55D-69 from acting on a matter due to the member's personal or financial interest therein, Class IV members of the Planning Board shall be called upon to serve, for that matter only, as temporary members of the Zoning Board of Adjustment. The Class IV members of the Planning Board shall be called upon to serve in order of seniority of continuous service to the Planning Board until there are the minimum number of members necessary to constitute a quorum to act upon the matter without any personal or financial interest therein, whether direct or indirect. If a choice has to be made between Class IV members of equal seniority, the Chairman of the Planning Board shall make the choice.

BE IT FURTHER ORDAINED, that this ordinance shall take effect following adoption and approval in a time and manner provided by law.

The following Ordinance #2022-002 (Appropriating a \$75,000 Grant to be Received by the Township for Improvements to Playground Facilities) was introduced by reference. Council President Qazi opened the Public Hearing on Ordinance #2022-002. As there was no one who wished to speak, a motion to close the public hearing was offered by Councilman Milman and seconded by Councilman Scalea. The council agreed by voice vote to close the public hearing. A motion to adopt Ordinance #2022-002 was offered by Councilman Scalea and seconded by Councilman Milman. The ordinance was passed on a roll call vote of 3 - 0 in favor. Council Vice President DiNuzzo and Councilwoman Marder were absent.

BE IT ORDAINED, BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than a majority of all members thereof affirmatively concurring), AS FOLLOWS:

 $\underline{\text{Section 1}}$ . The \$75,000 grant expected to be received by the Township from the New Jersey Division of Local Government Services Local Recreation Improvement Grant Program is hereby appropriated for the purpose of providing funds for improvements to recreation

facilities in Township parks, including all work and materials necessary therefor and incidental thereto.

Section 2. The capital budget or temporary capital budget, as applicable, of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Municipal Clerk and is available there for public inspection.

 $\underline{\text{Section 3}}$ . This ordinance shall take effect in accordance with law.
