MARLBORO TOWNSHIP COUNCIL MEETING

September 19, 2024

The Marlboro Township Council held its regularly scheduled meeting on September 19, 2024 at 7:00 P.M. at the Marlboro Municipal Complex located at 1979 Township Drive, Marlboro, New Jersey.

Council President DiNuzzo opened the meeting and announced that pursuant to the provisions of the Open Public Meetings Act, notice of this regularly scheduled meeting of the Township Council of the Township of Marlboro was emailed to the Asbury Park Press, the Star Ledger, and the Board of Education Office on September 17, 2024; published in the Asbury Park Press on December 26, 2023; posted on the Bulletin Board of the Municipal Building; filed in the Office of the Municipal Clerk and placed on the township's website and Channel 77.

Municipal Clerk, Susan A. Branagan called the roll.

PRESENT:

Council Vice President Milman, Councilman Qazi, Councilwoman Virdi and Council President DiNuzzo. Councilman Scalea was absent.

Also present: Township Attorney David L. Minchello, Esq., Business Administrator Jonathan Capp, Municipal Clerk Susan A. Branagan and Deputy Municipal Clerk Jennifer M. Johnson.

Citizen's Voice:

Frank Festa of Scotch Plains, New Jersey said that he has not received engineering approval for building on his commercial property. He also had questions regarding stormwater management.

William Waple of Marlboro, New Jersey discussed the conditions of sidewalks on Route 520 and ongoing sidewalk construction within the Township.

Robert Scutro of Marlboro, New Jersey had questions regarding the variance process with the zoning board for renovations to his garage.

Renzo Kolevonik of Marlboro, New Jersey had questions regarding the petition process for adding a question to an election ballot. It was explained to him that election laws are governed at the state level.

Council Speaks Out:

Councilwoman Virdi mentioned the Patriot's Day memorial service. Councilman Qazi presented a report on police, public works and water departments' activities. Council Vice President Milman thanked everyone who participated in the Patriot's Day memorial service. He said that Marlboro Day was a great success. He wished those who celebrate Rosh Hashanah a Happy New Year and he recognized Hispanic American Month. Council President DiNuzzo wished happy holidays to the Jewish community. She said that any concerns from residents will be addressed by the council at Marlboro Day. She attended a recent ribbon cutting at Faenza's Gourmet Market and reminded everyone that the upcoming economic development committee breakfast is scheduled at the Marlboro Township's Recreation Center. She thanked all who attended the Patriot's Day Memorial Service.

Councilman Qazi moved that the Council meeting minutes of August 15, 2024 be approved. This was seconded by Councilwoman Virdi, and passed on a roll call vote of 4-0 in favor. Councilman Scalea was absent.

AN ORDINANCE OF THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY, APPROPRIATING A \$475,000 GRANT TO BE RECEIVED BY THE TOWNSHIP FOR SIDEWALK IMPROVEMENTS TO TEXAS ROAD AND RYAN ROAD IN AND FOR THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY

In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Municipal Clerk and is available there for public inspection.

 $\underline{\text{Section 3}}$. This ordinance shall take effect in accordance with law.

WHEREAS, although property is provided through the 1033 Program at no cost to municipal and county LEAs, these entities are responsible for the costs associated with delivery, maintenance, fueling, and upkeep of the property, and for specialized training on the operation of any acquired property; and

WHEREAS, N.J.S.A. 40A:5-30.2 requires that the governing body of the municipality or county approve, by a majority of the full membership, both enrollment in, and the acquisition of any property through, the 1033 Program; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Marlboro that the Marlboro Division of Police is hereby authorized to enroll in the 1033 Program for no more than a one-year period, with authorization to participate terminating on December 31 of the year 2025; and

BE IT FURTHER RESOLVED, that the Marlboro Division of Police is hereby authorized to acquire items of non-controlled property designated "DEMIL A," which may include office supplies, office furniture, computers, electronic equipment, generators, field packs, non-military vehicles, clothing, traffic and transit signal systems, exercise equipment, farming and moving equipment, storage devices and containers, tools, medical and first aid equipment and supplies, personal protection equipment and supplies, construction materials, lighting supplies, beds and sleeping mats, wet and cold weather equipment and supplies, respirators, binoculars, and any other supplies or equipment of a non-military nature identified by the LEA, if it shall become available in the period of time for which this resolution authorizes, based on the needs of the Marlboro Division of Police, without restriction; and

BE IT FURTHER RESOLVED, that Marlboro Division of Police is hereby authorized to acquire any of the controlled property designated "DEMIL B through $Q^{\prime\prime}$ in the attached schedule if it shall

become available in the period of time for which this resolution authorizes; and

BE IT FURTHER RESOLVED, that Chief Peter J. Pezzullo of the Marlboro Division of Police shall develop and implement a full training plan and policy for the maintenance and use of the acquired property; and

BE IT FURTHER RESOLVED, that the Marlboro Division of Police shall provide a quarterly accounting of all property obtained through the 1033 Program which shall be available to the public upon request; and

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately and shall be valid to authorize requests to acquire "DEMIL A" property and "DEMIL B through Q" property that may be made available through the 1033 Program during the period of time for which this resolution authorizes; with Program participation and all property request authorization terminating on December 31st of the year 2025.
